NOTIFICATION

It is hereby notified for the information of all concerned that, in addition to the normal registration of students at Class IX for High Schools, registration at Class XI is to be re-introduced for students at Higher Secondary Schools. This action is taken to ensure that students are registered stream-wise so that unapproved change in the course of studies by some students is checked and also to discourage skipping of Class XI by students who apply for registration only at the Class XII stage. The application for Registration of Students (Higher Secondary Schools) in prescribed forms shall be forwarded by all heads of institutions with the requisite fees as under. It may be noted here that every student studying under the Mizoram Board of School Education shall be registered at Class XI as per rules and regulations of the Board.

The students belonging to schools that have not yet obtained opening permission from the Govt. of Mizoram shall register themselves under the Board on payment of registration fee with an additional amount of Rs. 50/- over the regular rate fixed as Registration fee.
