- a) Centre Superintendents shall appoint experienced and reliable Higher Secondary School/College Lecturers with good integrity as External Examiners in the concerned Subject(s) and a copy of the appointment order should be endorsed to the Controller of Examinations, MBSE. The number of Examiners are to be adjusted according to the number of candidates in a Centre so as to enable them to conduct practical examinations in a fair and smooth manner.
- b) It is the responsibility of Centre Superintendents to make arrangements for conducting practical examinations. If the Centre School does not have enough facilities, they may utilise the facilities of the neighbouring feeder schools, failing which, the facilities of the neighbouring Examination Centres may be utilised.
- c) Centre Superintendents shall make payments of remuneration payable to External Examiners appointed by them. Remunerations payable to External Examiner(s) and purchase of materials for practical tests in the Centres shall be met from the practical fees collected in the Centre.
- d) The rate of remuneration payable to External Examiners is Rs. 8/- per paper subject to a minimum of Rs. 250/-

- (d) The rate of remuneration payable to External Examiners is Rs.5.00 per paper subject to a minimum of Rs.200/-.
