All Heads of Institutions shall ensure that the student's name, father's/mother's name, date of birth, etc. submitted should be exactly the same as recorded in the birth certificate of the student.

Online submission and payment of fees by all High Schools to the MBSE will be opened during **July - September**, 2025 and last date for online submission and payment of fees will be 30th September, 2025 without late fee and 10th October, 2025 with late fee. Applications after last date shall not be entertained.
