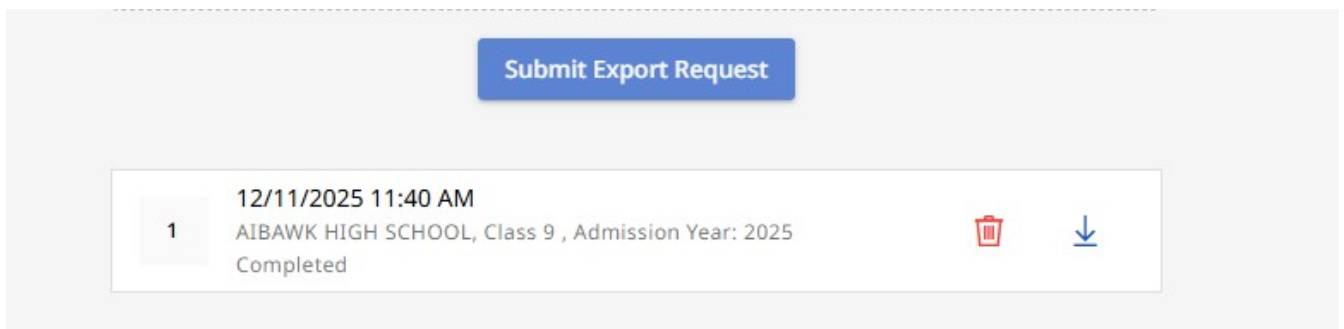

NOTICE

It is hereby notified for the information of all concerned that **every student studying under the Mizoram Board of School Education shall be registered at Class-IX as per rules and regulations of the Board** with payment of a requisite fee. The students belonging to schools that have not yet obtained opening permission from the Government of Mizoram shall register themselves under the Board on payment of registration fee with an additional amount fixed by the Board over and above the regular rate.

The application for registration is to be submitted online on the Board's portal i.e., www.mbseonline.com. Soft copy of application forms for students' registration will be available on the MBSE website and portal: www.mbse.edu.in and www.mbseonline.com. **The application forms duly filled shall be retained by the schools concerned for a minimum of two years.**

It may be noted that the particulars of students submitted during registration of students *will be directly used for HSLC Examination purposes* and as such, all Heads of Institutions are instructed to maintain due diligence so as to avoid errors. **All Heads of Institutions shall ensure that the student's name, father's/mother's name, date of birth, etc. submitted should be exactly the same as recorded in the birth certificate of the student.**

Online submission and payment of fees by all High Schools to the MBSE will be opened during **July - August, 2026** and last date for online submission and payment of fees will be **31st August, 2026 without late fee** and **7th September, 2026 with late fee**. **Applications after last date shall not be entertained.**

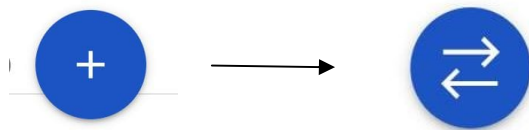
