It may be noted that the particulars of the trainee submitted during registration of students *will be directly used for D.El.Ed. Examination purposes* and as such, all Heads of Institutions are instructed to maintain due diligence so as to avoid errors. All Heads of Institutions shall ensure that the trainee's name, father's/mother's name, etc. submitted should be exactly the same as recorded in the birth certificate of the student.

Online submission and payment of fees by all DIETs to the MBSE will be opened from **3rd August, 2026** and last date for online submission and payment of fees will be **22nd August, 2026** and **24th – 29th August, 2026** *with late fee.* **Applications after last date shall not be entertained.**
